Whereas the Shoreline Advisory Committee ("SAC") in July 2025 submitted to Council recommendations for a comprehensive strategy to address the growing concerns regarding unauthorized and potentially unsafe shoreline structures on municipal land within the Rural Municipality of Victoria Beach (RMVB);

AND Whereas the SAC Recommendations were posted on the municipal website and noted in the VB Herald August 1, 2025, Issue;

AND Whereas Council heard 26 delegation comments on the SAC recommendations at regular Council meetings of August 05th and 19th, September 02nd and 16th, October 7th and received numerous emails;

AND Whereas Council passed Zoning Bylaw #1651 on 08 July 2025 where it states in Section 2.14: development shall be permitted with a development permit in riparian areas in accordance with the zone in which it is located provided it complies with the following conditions: (e) proposed development must not impose undue risk to people, property, or water quality, nor interfere with or unduly compromise the character, enjoyment, or sustainability of private or public property, and existing recreational uses and areas should be protected from potentially incompatible land uses that may threaten the ongoing viability of those areas, in accordance with the Development Plan;

Therefore, Be It Resolved to approve the process for conditionally regulating and permitting private structures on public property as attached in Schedule A.
